### "Detecting and Managing Glaucoma Progression"

Inder Paul Singh, M.D. - 1 hour GL Suites A & H

We will discuss the goals of glaucoma detection and determination of progression. Topics will include how to adequately examine the optic nerve head and nerve fiber layer clinically at the slit lamp. We will discuss various clinically signs to determine progression of the ONH. We will discus the various technologies used for automated nerve fiber layer evaluation, including GDx, HRT, and OCT. A significant portion of the hour will be focused on visual field progression, what parameters to focus on and what tools and techniques we can employ in both early detection and advanced disease. We will also discuss the usefulness of visual evoked potentials (VEP) in clinical evaluation and detection of progression in glaucoma and other optic nerve and optic pathway diseases.

"Can Evaluating and Treating Dry Eye Help Save Your Glaucoma Patient's Vision?"

We will discuss the affect ocular surface disease has on patients' compliance with disease treatment and follow up. We will discuss various strategies to help diagnose and treat ocular surface disease in the setting of glaucoma. We will discuss affects preservatives may or many not have on the ocular surface and the importance of the non active ingredients in the glaucoma treatment bottle. We will also discuss newer treatment modalities for treating ocular surface disease as well as a summary of current treatments including automated meibomian gland expression, manual meibomian gland expression, and use of autologous serum drops. There will be a short discussion on glaucoma delivery devices to help decrease the affect of glaucoma drops on the ocular surface and to help with patient compliance.

### **SPEAKERS**

### Blair Lonsberry, O.D.

Dr. Lonsberry obtained his Optometry degree from the University of Waterloo in 1996 after completing a Bachelor of Science and then Master of Science in Physiology from the University of Manitoba. He completed his residency in Primary Care Optometry at the Illinois College of Optometry in 1997, then joined the faculty at Southern College of Optometry in Memphis, TN. During his time at SCO, he completed a Masters in Education degree with an emphasis in adult learning.



Currently, Dr. Lonsberry is a Full Professor and the Clinic Director for the Portland Vision Center associated with Pacific University in Portland, Oregon.

Dr. Lonsberry is a Diplomate of the American Board of Optometry; a Fellow of the American Academy of Optometry, the Optometric Retinal Society, and the Optometric Glaucoma Society; and is on the executive committee of the Ocular Surface Society of Optometry.



### Ronald Melton, O.D.

Dr. Melton has lectured nationally and internationally on ocular disease and pharmacology at over 300 continuing medical education meetings. He sits on the editorial boards of *Optometric Physician* and *Primary Care Optometry News* and is a contributing editor to *Clinical and Refractive Optometry*. Dr. Melton has authored or co-authored over 100 papers on optometry and is the co-author of the popular annual "Clinical Guide to Ophthalmic Drugs" for *Review of Optometry*. Dr. Melton has

acted as an investigator in more than 50 clinical research trials.

### Inder Paul Singh, M.D.

Dr. Paul Singh completed his residency at Cook County Hospital - Division of Ophthalmology, and his internship at Michael Reese Hospital - Department of Medicine, both in Chicago, Illinois. He graduated from Finch University of Health Sciences/The Chicago Medical School in 1999. His undergraduate education was completed at Washington University in St. Louis, with a B.A. in Biology and Psychology. He completed his fellowship in Glaucoma at Duke University in July 2004, where he received the prestigious "fellow of the year" award.



Throughout his Ophthalmology training, Dr. Paul Singh has been involved with clinical research and has published papers on his research in several ophthalmology journals. He has presented

two papers at the annual meeting of the Association of Research in Vision and Optics. Dr. Paul Singh has developed expertise in a variety of surgical procedures, including: laser surgery, incisional surgery including trabeculectomy with antimetabolite therapy, combined cataract and glaucoma surgery, and glaucoma tube implant surgery.

A Racine, WI native, Dr. Paul Singh graduated from The Prairie School in 1990. He is an accomplished musician, having performed with his band, *Funkadesi*, in cities around the country. He returned to Racine with his wife Umang in 2004 to join The Eye Centers of Racine & Kenosha, founded in 1981 by his father, Dr. Kanwar A. Singh.



### Brad M. Sutton, O.D., F.A.A.O.

Dr. Brad Sutton received both his undergraduate and Optometry degrees from Indiana University. Upon graduating, he accepted a one-year residency in Ocular Disease and Surgical Comanagement at Omni Eye Services in Memphis, Tennessee, where he remained with the center as its director for five years before returning to IU. He is heavily involved in patient care, clinical teaching, and lecturing in the ocular disease courses. He is currently the Chief of Service at the Indianapolis Eye

Care Center.

Dr. Sutton's main areas of clinical interest include ocular disease and surgical management. He has given nearly 200 continuing education lectures on topics related to ocular disease at the local, state, national, and international levels. Dr. Sutton was named the Young Optometrist of the Year for the state of Tennessee in 1997-1998 and received the same award (President's Citation) for the state of Indiana in 2001.

#### Randall Thomas, O.D.

Dr. Thomas has lectured nationally and internationally on ocular disease and pharmacology at over 300 continuing medical education meetings. He sits on the editorial boards of *Optometric Physician* and *Primary Care Optometry News* and is a contributing editor to *Clinical and Refractive Optometry*. Dr. Thomas has authored or co-authored over 100 papers on optometry and is the co-author of the popular annual "Clinical Guide to Ophthalmic Drugs" for *Review of Optometry*. He is on the hospital staff at Northeast Medi-



cal Center, where he serves as the Ophthalmic Consultant to the Diabetes Management Committee and actively teaches on the Cabarrus Family Medicine Residency Faculty.

#### Things You Need To Know About Registering for WOA Convention:

- ◆ The deadline for early bird registration is September 1, 2013. After that date, the registration fee will increase by \$20.00.
- All courses will be filled on a first-come, first-served basis.
- ◆ The registration form is printed on both sides, one side is "Full Registration," and the other is "Partial Registration." Please complete only one side of the form!
- There are two choices for registration:
  - 1. <u>Full Registration:</u> One fee, including your choice of meals and all education classes you would like to take. Please still select all courses and meals you will be attending.
  - 2. <u>Partial Registration</u>: You choose which classes and meals you want to attend, and each is priced separately.
- If you plan to attend all or most of Convention, Full Registration is the way to go. If you can only attend a day or two, your best option may be Partial Registration. If you do Partial Registration and the total is more than Full Registration, you may pay the Full Registration amount even if you're not planning on taking all the courses just make sure to select which courses and meals you plan on attending.
- Incomplete forms will delay processing. Please make sure you have provided all necessary information, and type or print clearly on the form. Even if you are doing full registration, you are still required to check off the meals and classes you plan on attending.
- ◆ There is an option for the entrée at Saturday's President's Luncheon. Please select either the beef or chicken entrée. If you don't make a selection, you will automatically receive the chicken option.
